Dear Chairman Manchin, Chairman Pallone, Chairwoman Hirono, Chairman Rush, Ranking Member Barrasso, Ranking Member Hoeven, Ranking Member Rodgers, and Ranking Member Upton:

We write today as a coalition of business, government, environmental, and consumer leaders, to urge you to convene a legislative hearing to consider the Main Street Efficiency Act of 2021. The legislation would establish a federal grant program at the U.S. Department of Energy (DOE) to make small businesses across the nation more energy efficient.

As you know, small businesses are the undisputed backbone of the U.S. economy, providing nearly half of the employment in the United States and half of its gross domestic product. The extended economic uncertainty caused by the Covid-19 pandemic has heavily impacted these critical enterprises.

Congress can help Main Street regain competitiveness while exiting the economic crater caused by the Covid-19 pandemic by considering the Main Street Efficiency Act, introduced in the 117th Congress as S. 2665 by Sen. Catherine Cortez Masto of Nevada and H.R. 4903 by Rep. Peter Welch of Vermont. Senate co-sponsors include Sen. Jeanne Shaheen, Sen. Kirsten Gillibrand, and Sen. Cory Booker. Co-sponsors in the House include Rep. Marilyn Strickland, Rep. Mondaire Jones, Rep. Mike Doyle, Rep. Marc Veasey, Rep. Lisa Blunt Rochester, Rep. Val Demings, Rep. Scott Peters, Rep. Paul Tonko, Rep. The Main Street Efficiency Act would establish a grant program at the DOE to supplement, not supplant, utility demand-side management investments in small businesses. This would result not only in energy savings for businesses and avoided carbon emissions, but more critically to these struggling enterprises, it would reduce monthly operating costs for years to come, allowing entrepreneurs to re-invest in their businesses and employees. Due to the value MSEA would bring to the small business community, including minority and women-owned businesses, the legislation has the support of a diverse list of national <u>chambers of commerce</u> and elected official <u>policy organizations</u>.

Across the United States, small businesses account for as much as half of any utility's energy demand, yet, even under the best of economic times, investment in the sector lags, with less than 10% of most budgets aimed at small businesses. Nationwide, small businesses spend \$60 billion annually on utility bills, which are often among the top-3 largest expenses for any small business. These bills could be cut by as much as 30% with energy efficient upgrades, like those that would be funded under the Main Street Efficiency Act.

As you consider investments in U.S. competitiveness, we urge you to invest in Main Street.
